Pursuant to Article 108 of the Law on Public Procurement ("Official Gazette of RS", No. 124/2012, 14/15 and 68/15) and the Report of the Commission for expert assessment of bids No. 404-122/18-12 of 28 September 2018 for the public procurement of goods No. 34/18 "Upgrade and support of the CLIDATA meteorological information system produced by ATACO spol. s.r.o. from the Czech Republic", Procuring Entity, the Republic Hydrometeorological Service of Serbia, hereby issues the following:

DECISION ON AWARDING THE CONTRACT

for the procurement of goods "Upgrade and support of the CLIDATA meteorological information system produced by ATACO spol. s r.o. from the Czech Republic" to bidder ATACO spol. s.r.o. Ruskà 83/24 CZ 700 30 Ostrava Vitkovice Czech Republic, whose bid No. 404-122/18-9 dated 20 September 2018, with the price of EUR 33,800.00 that is, RSD 4,001,940.28 on the day of bid opening, has been assessed as acceptable for the Procuring Entity.

Argumentation

In accordance with the Decision on initiating an open public procurement procedure No. 404-122/18-1 of 27 August 2018, the procedure for the public procurement of goods No. 34/18 – Upgrade and support of the CLIDATA meteorological information system produced by ATACO spol. s.r.o. from the Czech Republic – was initiated.

A call for bids was published on the Public Procurement Portal and on the webpage of the Procuring Entity www.hidmet.gov.rs on 30 August 2018, and a notice on the change of the bid submission deadline on 5 September 2018.

The Procuring Entity received one bid by the end of the deadline for the submission of bids.

Upon the bid opening procedure, the Public Procurement Commission made an expert assessment of bids and produced a report No. 404-122/18-12 of 28 September 2018. The Public Procurement Commission has ascertained the following:

1. Information on the public procurement

Procuring Entity: Republic Hydrometeorological Service of Serbia, Kneza Viseslava Str. 66, Belgrade;

Procurement No.: 34/18; Reference No.: 404-122/18; Date: 28 September 2018;

Type of procedure: This public procurement procedure is **an open public procurement procedure**, in line with Article 39 of the Law on Public Procurement ("Official Gazette of RS", No. 124/2012, 14/15 and 68/15);

Estimated value of the public procurement (with and without VAT): RSD 4,351,666.00; The procurement, included in the Public Procurement Plan for 2018, page 6, item 46, shall be performed from budget compartment 37, function 410, economic classification 426, with the amount of RSD 3,751,666.00 relating to the source of financing 01 and the amount of RSD 600,000.00 to the source of financing 06;

Bid submission deadline: 27 September 2018 at noon;

The criterion for the selection of the most favourable bid is the lowest price.

The reasons justifying the application of this particular method relate to the resources that have been planned and approved for this purpose, with the total value of the goods of the same kind not exceeding the upper limit of the small value public procurement annually, that is, not exceeding the total amount of RSD 5,000,000.00.

2. One bid was submitted timely, within the bid submission deadline, by the following bidder:

There were no untimely bids.

Upon the finalization of the bid opening procedure, the bid was subjected to an expert assessment, that is, to a detailed examination and control of the fulfillment of conditions for participation in the procedure for the selection of the most favourable bid for awarding a public procurement contract.

The Commission has ascertained the following:

- the bidder has submitted a timely bid in accordance with the tender documentation;
- the bidder has submitted completed, signed and certified forms required by the tender documentation: Statement on the fulfilment of requirements for participation in a public procurement procedure from Article 75 and 76 of the Law on Public Procurement ("Official Gazette of RS" No. 124/2012, 14/15 and 68/15), Bid form, Model of the contract, Form of cost structure and Statement on independent bid as evidenced by the list of received documents annexed herewith officially translated by the RHMSS interpreter;
- the bidder has submitted a bid with the terms of payment and bid validity period which are in compliance with the requests of the procuring entity set out in the tender documentation;
- the price does not surpass the estimated value of the public procurement;

the bidder – producer of the software, that is, of the subject matter of the procurement, has been providing maintenance services at the same price in the

previous years;

the bidder received the letter no. 404-122/18-11 requesting additional clarification related to the inconsistency between the procurement subject matter delivery date indicated in the bid form and the one indicated in the submitted model contract, which the bidder subsequently corrected and resubmitted the form within the given deadline;

bearing in mind that only one offer has been received, it was not possible to compare prices with other bidders. The Commission has also ascertained that an attempt was made to compare prices (for the same or similar goods or services) with the prices from the Internet and concluded that the producers of the goods or

services of this or similar kind do not publish prices on their websites;

- the Procuring Entity has been a user of this database since 2006 and in the previous years, due to necessary modernization, it stayed in touch with the bidder (owner of the software) that has submitted bids in the course of the past years for the required upgrades and maintenance at the same price, which could be regarded as a comparable market price.

Having performed the expert assessment of bids, the Commission has ascertained that the bid is acceptable, i.e. that it does not have any significant deficiencies, that it neither limits nor conditions the rights of the Procuring Entity or the obligations of the bidder, and that it does not exceed the gross estimated value of the public procurement, so that it therefore meets the conditions required for a decision on awarding the contract, in accordance with Article 107 paragraph 3 of the Law on Public Procurement.

Based on the above, and in accordance with Article 108 of the Law on Public Procurement ("Official Gazette of RS", No. 124/2012, 14/15 and 68/15), Procuring Entity, the Republic Hydrometeorological Service of Serbia, has decided as stated in the wording of the decision.

Legal precept:

A Request for the protection of rights against this decision may be submitted to the Procuring Entity within 5 days from the receipt of the decision.
